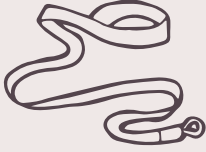

DOG EXPERIENCE

Have you ever had pets before?

Are you aware that it takes a lot of patience, time and understanding, especially when settling in, and that the dog may regress in its development as a result of the move? (e.g. lack of house-training, anxiety, insecurity, behavioural problems, etc.).

Are you aware that a rescue dog can mean a lot of work due to its history? (Education & training) Are you prepared to work intensively with a dog trainer on possible problems in this case?

Are you aware that the dog may need a long time to settle in with you? (Up to a year) And that the judgement of the dog's character is made to the best of our knowledge and belief, but that each animal goes through an individual development, depending on its history and situation.

FINANCIAL SITUATION

Are the financial resources sufficient to cover the running costs as well as any extraordinary costs (e.g. operations, medication, etc.)?

How much budget do you have available each month to cover the running costs of keeping the dog? (food, dog tax, liability insurance etc.)

Are you aware that older dogs (especially those with known pre-existing conditions) can incur higher costs?

Are you aware that the dogs are generally checked by the vet and made ready to leave the country? However, detailed examinations with e.g. complete x-rays cannot be carried out, so that not all diseases can be ruled out.

Have you looked into the possibility of health and/or surgery insurance for the animal?

DATA PRIVACY

Consent under data protection law

The personal data provided in the questionnaire, in particular name, address, telephone number, etc., which are necessary and required exclusively for the purpose of conducting the resulting preliminary interview, are collected by 'Mimo Dogs Associação de proteção animal', hereinafter referred to as the 'contractual partner', on the basis of legal authorisations.

Rights of the data subject

In accordance with Section § 15 DSGVO, you are entitled at any time to request comprehensive information from the contractual partner about the personal data stored about you.

In accordance with Section § 17 DSGVO, you can request the contractual partner to correct, delete and block individual personal data at any time. In addition, you can exercise your right to object at any time without giving reasons and amend or completely revoke the declaration of consent you have given with effect for the future. You can send your cancellation in writing - either by post, e-mail or fax - to the contractual partner. This will not incur any costs other than the postage and transmission costs according to the applicable basic rates.

Note on data protection

By sending the completed self-disclosure form by e-mail/post/WhatsApp etc., the sender agrees that 'Mimo Dogs Associação de proteção animal' will store all data and pass it on for appropriate preliminary and follow-up checks.

Irrespective of this, 'Mimo Dogs Associação de proteção animal' will also forward data to organisations associated with animal welfare due to non-contractual or dubious behaviour. According to the Federal Data Protection Act, these reports may only be made insofar as this is permissible after weighing up all the interests concerned. In this respect, the sender/signatory releases the animal welfare organisation from data protection secrecy by sending and signing the relevant documents. However, the animal welfare organisation 'Mimo Dogs Associação de proteção animal' only stores and transmits the data to its animal welfare partners in order to provide them with information to assess the reliability/seriousness of natural or legal persons. The animal welfare partners of 'Mimo Dogs Associação de proteção animal' are exclusively animal welfare organisations in Europe.
